Unless they raise the cash, the creche could close in April, a victim of Wirral Council making 99.47m cuts to avoid government capping. Closure would not only leave the three creche workers without jobs and the toddlers with nowhere to go, it would also stop their mums from helping out in the school next door.

The creche opened in a classroom seven years ago, but only 16 months ago it moved into a purpose-built £16,000 building in the school grounds.
Sponsored toddle organiser Rhona Coffy, 30, said: "If we let the creche close we've got no chance of reopening it again.
"People around here feel very strongly about it. They are determined to keep it open."
Parents have also collected an 800-name petition which they plan to give to councillors at Monday's council meeting at Wallasey Town Hall.
